RESEARCH AWARDS

The SLIA wishes to announce the SLIA Awards for Architecture 2023/2024.

The Awards Committee was able to make all the arrangements to submit entries on line with exclusive web portal to showcase shortlisted members work more visible to public. This year the Awards will be presented the Annual Sessions during the Inauguration ceremony 2024. Presentations will be held in 2024 for the Short-Listed Nominees.

1. BACKGROUND

In this context the SLIA wishes to encourage its members to engage in **research work** and recognize their contribution towards knowledge dissemination. Towards this end, in addition to the Research Award which was already created to offer recognition and appreciation of members' contribution in the areas of Architectural research, a Publication Award was created in 2008 to offer recognition and appreciation of members' contribution in the areas of Architectural publications.

2. CRITERIA FOR SELECTION

SLIA Architectural Research Award

The "SLIA Architectural Research Award" will be offered on an annual basis (coinciding with the SLIA Annual Sessions) to recognize and appreciate outstanding contributions to research in the last 05 years.

The selection will be based on self-evaluation of one's work on the basis of the following criteria:

(Minimum 05 submissions of each will carry full marks)**

Notes:

* Indexed Journals are those that are tracked by reputable indexing services such as the Science Citation Index, Social Science Citation Index, Arts & Humanities Index, RIBA Index, Cambridge Scientific Abstracts, etc. Proof of index must be submitted. Usually, the Journal cover page (or its table of content page) will list the indexing service/s used. A photocopy of such page is sufficient.

** Publications based on creative work should not be a mere collection of pictorial evidence, but a valued research work. The author's research contribution must be submitted in narrative form.

The Council may decide the number of Awards from among those applicants who meet the minimum criteria. A ranked Award (First, Second, Third or Gold, Silver, etc.) may be decided upon by the Council.

3. ELIGIBILITY

All members of the Sri Lanka Institute of Architects are eligible to apply.

SLIA Architectural Research Award

The eligible works are those publications and conference presentations that appeared in print during the 05 year period preceding the closing date of application. Points shall not be claimed for publications and works for which an "SLIA Architectural Research & Publication Award" has been previously awarded.

4. METHOD OF APPLICATION

Applicants should submit via the online awards application portal only www.awards.slia.lk with a self-evaluation of their published work in the annexed format. Copies of all publications must be annexed.

Reference to published work should be given in the following format:

A. Journal / Other Publications

Name of Journal or Publication (in Italics), Year of publication, Place of publication: Name of publisher.

Vol/Issue Nos, page nos.

Example:

Architectural Science Review, 1997, Sydney, Australia, Vol 40, issue 2, pp. 123-135

B. Conference Proceedings

Name of Conference / Event (in italics.), Date and Year of Conference, Place of event, Page nos. in proceedings.

Example:

ARCASIA Regional Conference, November 2-3, 2004, Beijing, China, pp. 13-15

C. Keynote addresses / others

Name of Event (In italics), Date and Year of event, Place, (in addition, proof of event must be submitted.)

D. Books

Name, Date of publishing, ISBN number (if any.), Sources of Information in brief.

5. JUDGING

Awardees will be selected by a Panel appointed by the Council. The panel will consist of the following:

1. Senior Vice President. (Convener)
2. Chairman, Board of Architectural Education;
3. Chairman, Board of Architectural Publications;
4. Two members of the Institute who, in the opinion of the Council, have made substantial contributions to Architectural Research and Architectural publications.
5. Reviewers for specific areas of study - (Members or Non-members)
